4. GENERAL BODY

Annual General Body will meet once in a year i i.e. in the month of June

ii. FUNCTIONS

a) To pass the budget for the ensuring year and approve the expenditure statement of previous year.

b) To approve the reports of the activities of the Society.

c) To elect the Executive Committee etc.,

d) To appoint Auditor

i. Executive Committee: shall consist of Seven (7) Members and out of them, 5. the following office bearers shall be elected by the Executive Committee, Viz., Chairman, Vice - Chairman, Secretary, Joint Secretary and Treasurer.

ii. The members of the executive committee (Governing body) shall be duly bound to attest the signatures of all the members of newly elected Executive Committee and to see that the said signatures of the outgoing Governing Body tally with the annual list as filed with Registrar of Societies before 15 Days the succeeding month in which elections were held.

FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

1. President:

He/ She presides over all the members of the General Body and Executive Committee. He can cast his vote in the case of a tie in decision making. He can supervise all branches of the society.

2. Vice - President:

He/She shall assist the President in discharging his functions. In the absence of the Chairman he will perform the duty of the Chairman as entrusted by the Chairman.

3. Secretary:

He/ She is the Chief Executive Officer of the Society and Custodian of all records relating to the society and correspondent on behalf of the Society. He has to take on record all minutes of the Society. Would convene both the Executive Committee and General Body of the society with the permission of the Chairman. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.

Secretary is exclusively authorised to open and operate Bank Accounts and to borrow funds from Banks & Financial Institutions and to execute all necessary documents to obtain such loans on behalf of the society.

Secretary is further authorise to enter into any agreements on behalf of the Society with Govt., Universities, Local bodies, Companies, Firms and Individuals.

4. Treasurer:

He/She is responsible for all financial transactions and Funds of the society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the society jointly with the Secretary or Chairman.

5. Quorum:

1/3 (One Third) of the total members for General Body Meeting and ¼ for Executive Committee meeting.

6. Funds:

The funds shall be spent only for the attainment of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means.

The Society is hereby authorised to borrow funds from any Banks, Institutions or Individuals for the purpose of the objects of the Society. And the society is also authorised to mortgage/pledge the movable and immovable properties of the society for the above and to repay such loans along with interest out of funds of the society.

The Executive body of the society is authorised to depute any office bearer of the society to execute the documents for any borrowings on behalf of the society and the society shall board by such documentation executed by such authorised representative

The investment of funds of the Society shall be made in accordance with the provision of Section 11(5) of the Income Tax Act, 1961.

7. ACCOUNTS & AUDIT:

The Accounts of the society would be maintained as required under the applicable laws and statues and that an audit of the accounts will be carried out by a Chartered Accountant

No Amendment or alteration shall be made in the purpose of the association unless it is voted by 2/3rd of the members present at a special meeting convened for the purpose and confirmed by 2/3rd of the members present at a second special meeting and

The objects of the Society and the by-laws of the Society will not be modified, changed or altered or substituted without the prior consent of Director of Income Tax (Exemptions).

9. WINDING UP:

In case of the dissolution of the Society, the properties of the Society will be handed over to a Society / Trust having similar objectives and which is registered U/s 12 (A) of the Income Tax Act, 1961.






